

Shipping Instructions

<u>Logistic services</u> (upon reservation):

• **Advance warehouse**: the goods have to be shipped to our attention from 2/3 days before assembly.

The goods will be then delivered directly to the stand.

The management of your shipment will be charged according to our official tariff - attached

- All shipments must be advised using the attached order form.
- Please use only the attached label.
- Unloading/loading of incoming vehicles on set-up/dismantling days: to be agreed day and time
- Other services on request:
 - During the event you can request the service of collection, storage, return of materials and empty packaging.
 - Packaging of outgoing materials
 - Transports to and from your headquarters
 - All Risks Insurance

- 4. A representative of the company must be present at the stand at the time of delivery and collection. Mel S.r.l. is not responsible for any theft or damage to material left unattended or not properly packed.
- 5. Please ensure the shipment: Mel S.r.l. is responsible for the goods only from the moment of takeover until delivery. Mel Srl does not insure all-risks.

For any damage caused by us during the performance of the services is recognized only reimbursement under insurance conditions RC (not applicable for goods left unattended).

- 6. Mel S.r.l. is not responsible for goods left unattended by the stand.
- 7. Mel S.r.l. is not responsible for errors, delays, failed pick up/delivery by couriers/carriers/freight forwarders.
- 8. All materials left in storage at our depot for more than 3 days after the event will be invoiced with a surcharge of 100%. After 30 days following the end of the event the materials will be removed.
- 9. All shipments must be advised using the order form. Failure to give notice of the shipment will result in the charge of an extra \in 75.00.
