Awards

We offer our members the chance to apply for industryand UKCPA-sponsored awards of up to £1500 in value. These are a recognition of excellence and innovation in various therapeutic areas and include funding to present the work at one of our events.

Research grant

In partnership with Pharmacy Research UK we offer up to £50,000 in our Clinical Pharmacy Research Grant.

This is one of very few research awards for clinical pharmacy and recognises the need to support practitioners to develop their research skills in addition to building and maintaining the evidence-base for pharmacy practice and the profession.

The funding is aimed at pharmacists that are seeking to undertake research in their area of clinical practice, while further developing their research skills. While the quality of applications is of paramount importance, priority is given to lead applicants for whom the project is their first as a Principal Investigator.

Event funding

We provide several opportunities to support attendance at UKCPA events, including free conference or masterclass attendance as part of an award package, and industry-sponsored conference attendance for early years practitioners.


UKCPA offer a number of educational events throughout the year, which cater for all levels of practice.

The aim of this masterclass is to enable participants to understand the complexities of VTE prevention in specific patients groups, the side effects of VTE chemical prophylaxis and treatment including heparin-induced thrombocytopenia (HIT) and its management, and bleeding complications associated with anticoagulants, including the new oral anticoagulants (NOACs)

Learning Outcomes:

- Discuss the complexities associated with specific patient groups requiring VTE prophylaxis, including patients with lower limb casts, patients requiring extended VTE prophylaxis and the management of needle-phobic patients

Multi-specialty care for a patient with a diabetic foot

Wednesday 24th September 2014

Overview

This day covers the journey of a complex patient with co-morbidities from clinic to hospital discharge via an in-patient stay. It will discuss medicines choice and optimisation, together with pain, infection and diabetic management. It will also cover how the patient is presented for surgery, including his pre, peri and post operative management, and the potential problems that may be encountered along the way. It is a must attend event for pharmacists working in a generalist role.

Background

'Andrew', an insulin treated patient, attends a diabetic clinic and is sent to hospital because his blood sugar level is uncontrolled. It is discovered that he has an infection and is suffering pain, on top of his diabetes, which his GP has tried to manage but unsuccessfully. Whilst in hospital, Andrew suffers a hypoglycemic episode and requires a surgical procedure.

Learning Outcomes

At the end of this masterclass, participants will be able to:

- Identify pharmacological and non pharmacological treatments for the management of neuropathic pain and relate to national guidance
- Discuss the peri-operative drug management issues involved in the management of surgical patients
- Identify antibiotic options for the treatment of diabetic foot infections, including in the OPAT setting
- Discuss pharmaceutical monitoring and risk reduction strategies for post-operative epidural analgesia
- Discuss how to optimise glycaemic control and prevent diabetic complications
- Discuss the therapeutic options for the management of septic shock
- Discuss the potential for medication errors at all stages of the patient's journey
