I was appointed to EPHA's Board in 2017, becoming Vice President later that year, and President in 2020, a role I would be happy to continue if re-elected. I have helped steer EPHA successfully through recent transitions, including the recruitment of our new Director General.

I have worked in public health since 2008 on societal challenges in public health and health equity and have extensive experience of managing organisations, projects and partnerships in Europe. I would like to continue working to grow EPHA's work in health inequalities, building better links with WHO Europe, and ensuring EPHA's ongoing sustainability and success.

Dear EPHA members,

I wish to stand for re-election to the EPHA Board for the 2021-23 term. I have hugely enjoyed working for EPHA on the Board since 2017, and particularly following election by my Board colleagues as President last year.

I am currently Director of the Health and Europe Centre, a social enterprise in the National Health Service in the UK. The Centre works to bring European learning, practice and policy to the local NHS public health community, focussing on health inequalities and social determinants of health. The Centre has a unique understanding of how innovation can be practically transferred and implemented between health and social care systems in Europe.

I have 11 years' experience of directing and growing an organisation, with responsibility for all aspects of leadership and management. During this time I have grown our EU project portfolio from a values of €400k to the current €67m, and so have significant experience of building and bidding for EU projects, their financing, management and reporting.

English is my mother tongue, and I speak fluent Italian and good French, and have a working knowledge of 3 other EU languages.

Both my role as Director of the Health and Europe Centre, and as part of the EPHA Board, require me to have good interpersonal skills and be able to establish and maintain effective working relationships. Indeed, I have been able to bring some of these relationships to the EPHA table, making introductions for our new Director General to colleagues at WHO Europe and elsewhere.

I have always had a strong interest and knowledge of international relations, and indeed am continuously expanding this through my membership of organisations such as the Institute for International Affairs in London. I have worked in international public health since 2008, on a wide variety of topics such as diabetes, dementia, sexual health, health systems, perinatal mental health, social inclusion, men's mental health and healthy diets.

I hope that I will be able to continue to use my skills to serve EPHA members on the EPHA Board; and to continue to help grow and develop EPHA over the next two years.
