

## Q5 Did the keynote meet your educational needs?



## Q6 To provide examples of different medicines pricing strategies









## Q19 Did the keynote meet your educational needs?



## Q20 To discuss the advantages of Big Data in decision making processes



### Q21 To avoid getting lost in the jungle of Big Data









# Q73 To describe the generic structure and focus of accreditation standards for patient safety




